Directed funding has been provided under the CRISI program and the Restoration and Enhancement Program per FFY 2017/FFY 2018 US DOT Appropriations, \$2.2 million and \$18.8 million respectively.

^{3/} Due to Hurricane Florence, the FRA extended the application to 10/12/2018 from 9/17/2018.

^{4/} Of the \$325 million available, \$9,977,500 has been set aside for Special Transportation Circumstances, which will be made available under a separate NOFO. Also, \$3.25 million will be set aside for award and program oversight.
